Subject: – Centralized Merit Based counseling for admission to Sponsored DNB (Post MBBS and Post Diploma) seats – 2024 admission session- reg.

1. NBEMS shall be conducting Centralized Merit Based counseling for admission to Sponsored DNB (Post MBBS and Post Diploma) seats – 2024 admission session, schedule for which shall be notified in due course.
2. The indicative seat matrix for Sponsored DNB (Post MBBS and Post Diploma) courses- 2024 admission session is published herein below. The Final Seat matrix shall be notified before the conduct of Centralized Merit Based Online Counseling on NBEMS website.

3. Eligibility Criteria for Sponsored DNB (Post MBBS) seats:

- I. Candidates who are working in a Government (State/ Central/ Autonomous/ PSUs, etc.) organization on a regular basis are eligible for Sponsored DNB (Post MBBS) seats.
- AND
- II. Candidates must be in possession of MBBS qualification recognized as per the provisions of the NMC Act, 2019 and permanent registration certificate of MBBS qualification issued by the Medical Council of India/ State Medical Council.

AND

III. Must have "**Qualified**" NEET-PG 2024.

4. Eligibility Criteria for Sponsored DNB (Post Diploma) Seats:

- I. Candidates who are working in a Government (State/ Central/ Autonomous/ PSUs, etc.) organization on a regular basis are eligible for Sponsored DNB (Post Diploma) seats.
- AND
- II. Candidates who have passed the final examination leading to the award of Post Graduate Diploma from Indian Universities which are duly recognized as per provisions of NMC Act 2019 i.e. have passed final examinations for Post graduate diploma qualification on or before **31st May, 2024**.

AND

III. Candidate must have “Appeared” in DNB-PDCET 2024.

5. All such candidates who fulfil the aforesaid eligibility criteria and are desirous for opting the sponsored DNB (Post MBBS and Post Diploma) seat are required to submit his/ her request to their parent organization. The Cadre Controlling Authority should issue an NOC in favor of candidates and submit to NBEMS, strictly as per the format prescribed by NBEMS.

6. The duly filled and signed NOC should only be submitted at CWP of NBEMS latest by 10th January, 2025. Steps to submit NOC through CWP are as follows:
