**Subject: Schedule for Offline Centralized Merit Based Counseling - FNB (FPIS) Courses for International Students - 2023 admission Session**

1. The Centralized Merit Based Counseling for admission to FNB (FPIS) courses for 2023 Admission Session shall be conducted by NBEMS via offline mode as per the schedule mentioned below: -

Sr. No.	Counseling Process	Schedule
1.	Registration for Counseling	28-06-2024 to 01-07-2024 (1200 hrs.)
2.	Submission of prescribed documents and seat choices (refer to para 5)	28-06-2024 to 01-07-2024 (1200 hrs.)
3.	Processing of eligibility and allotment	02-07-2024 to 03-07-2024
4.	Result of seat allotment	03-07-2024
5.	Payment of First Year Course fee and Submission of Indemnity Bond	03-07-2024 to 08-07-2024 (1700 hrs.)
6.	Physical Joining at the allotted hospital	03-07-2024 to 12-07-2024 (1700 hrs.)

2. Participation in the offline Counseling shall be strictly as per the eligibility criteria mentioned in the Information Bulletin for FNB – FPIS 2023 Admission Session.
3. Following steps must be completed to participate in the counseling:
- Payment of registration fee for offline counseling
  - Submission of prescribed documents
  - Submission of Choices
4. The Candidates are required to pay the Counseling registration fee of Rs. 2500/- to register for the counseling. Payment gateway charges, if any, shall be borne by the candidate. Registration fee for counseling shall not be refunded under any circumstances once the candidate has been registered for Counseling. The registration fee shall be deposited in the account details mentioned below:

Thereafter, the candidates are required to submit the following **self-certified** scanned copies of documents (through email at [counseling@natboard.edu.in](mailto:counseling@natboard.edu.in)) as indicated in: Information Bulletin FET-2023-FPIS (Fellowship Programme for International Students) 2023 Admission Session –
- MBBS/ Primary Medical Qualification Degree Certificate.
  - Degree Certificate of post graduate medical qualification equivalent to the eligible feeder issued **on or before 31<sup>st</sup> December 2023**.
  - Post Graduate Medical Qualification Registration Certificate issued by the Medical Council of respective country.
  - No Objection Certificate issued by the Medical Council/ Government of respective country for permission to work in India for the period of Fellowship.
  - Temporary Registration with the National Medical Commission, New Delhi, India for the duration of FNB course is to be submitted after seat allotment.
  - Valid travel document (Passport) and valid permission (visa).
  - Copy of receipt towards payment of Counseling fees.
  - Declaration and Certification by the Candidate (cum Choice of Preferences) for opting a seat - FET-2023-FPIS – 2023 Admission session([Click here for the format of certificate for submitting the Choices of Preferences](#)).

7. The verification of eligibility (documents verification) shall be done by NBEMS from 02-07-2024 to 03-07-2024.
8. The seat allocation will be done in order of merit cum choice/ preference of seats indicated by the candidate during the registration/choice submission process and the provisional seat allotment result of the eligible candidates shall be published at NBEMS website.
9. For joining the allotted seat, the candidate is required to pay First year course fee [non-refundable] as per Chapter 14 of the FET 2023 Information Bulletin within the stipulated time. After the payment of First year course fee, the seat allotted to him/her will be FROZEN in his/her favour. The details regarding the submission of annual course fee shall be communicated to the candidate in the seat allotment letter issued by NBEMS.
10. The candidates are also required to submit the duly signed undertaking for **Indemnity Bond of Rs. 5,00,000/-** ([Click here for the format of Indemnity bond](#)) before joining the Fellowship Programme.
